#### **MAIN NATIONALITIES & NUMBERS**

The population of the United States of America is **approximately 329 million**. There are six recognized races in the USA: White, American Indian and Alaska Native, Asian, Black or African American, Native Hawaiian and Other Pacific Islander and people with two or more races. Hispanic and Latino Americans account for just over 16% of the whole population.

#### **IN-DEMAND JOBS IN THE USA**

Many of **the most in-demand jobs in the US** are within the healthcare, clean-energy and technology industries. The ten roles listed as most indemand\* in 2020 are: Solar Energy Technician, Wind Energy Technician, Nurse Practitioner, Software Developer, Physical Therapist, Registered Nurse, Health Services Manager, Data Analyst, Digital Marketing Expert, Digital Content Specialist and Information Security Analyst.


## **AVERAGE SALARY**

Salaries in the US vary greatly depending on the type of occupation and the location. Employees working in large metropolitan cities have higher costs of living and tend to have higher levels of pay. The average wage for workers in the US was \$48,672\* at the end of 2019. Workers in professional management and related jobs were earning \$69,109 as a median salary, whilst service workers earned an average of \$31,252.

#### EMPLOYERS SPONSORSHIP

Non-US citizens can apply for a H1B visa sponsor to get a job in the US. The visa applicant must find a job in the US that is prepared to hire them and there is an application fee that must be paid. **The fee for H1B is now \$560** and the applicant must attend an interview at the US Embassy and provide all of the required documents, whilst the employer must also provide rationale as to why they are hiring a foreign worker.

#### **AMERICAN CITIZEN & RESIDENT SPONSORSHIP**

A **US citizen** is able to file a petition for certain relatives to become a lawful resident of the US through a Green Card. Someone can file a petition for their husband or wife, or their children. US citizens aged 21 and over are also able to petition for parents and siblings. The petition involves filling in a Form I-130 and providing required documents. #### **DIVERSITY VISA LOTTERY**

The US has a lottery with a certain number **(usually 50,000)** of immigrant visas available each year that will be provided with a US Permanent Resident Card. The Diversity Visa Lottery has been in operation for over 30 years but the requirements and eligibility criteria has been updated regularly over recent years.



# Settling Down in the USA



#### **SOCIAL SECURITY & HEALTH INSURANCE**

**The US** recently changes the policy on health insurance requirements for visitors. The ruling applies to immigrants who are deemed to financially burden **the US healthcare system** and requires visitors to obtain health insurance within 30 days of arriving in the US. This does not apply to tourists travelling with an ESTA, however travel insurance with medical cover is recommended for travellers. To work in the US, you require a Social Security Number, which can be obtained by filling in Form SS-5. There are three types of social security cards; one for US citizens and permanent residents, one for temporary workers and another which is tax related.



#### **AMERICAN BANK ACCOUNT**

To open a **US bank account**, you will need a **Social Security Number**, be a legal US resident with a valid US address and be aged 18 or over. Banks may also ask for a **US driving licence** or **state ID** as proof of identity.



#### **RENTING OR BUYING PROPERTY**

In comparison to buying property in the UK, **house prices in the US are usually quite affordable** but it depends on the area you are looking at. If you are looking at renting, you may need to provide documentation to show financial stability as you will not have a **US credit record**. You will also need documents such as passport, proof of employment and usually a Social Security Number. Buying a house is similar, with a Social Security Number, or Individual Taxpayer Identification Number to enable you to purchase a property.

## **DRIVING LICENSE**

A US drivers license is issued by each state, as each one has different requirements and procedures, which you can check on the Department of Motor vehicles that is applicable to your state. In the majority of US states, you require a Social Security Number to enable you to get issued with a driving license. You may also be required to provide your foreign driver's license, passport and proof of immigration status.





### **STATE TAXES**

In the US there are **tax residents and non-tax residents and immigrants** that are classified as tax residents must pay US taxes. Permanent residents and green card holders are classed as tax residents and income must be reported to the IRS.
